

Subject: Privacy statement pursuant to Art. 13 of EU Regulation 679/2016, for those who interact with the web services of Jindal Saw Italia S.p.A.

Jindal Saw Italia S.p.A. acknowledges the importance of protecting personal data and undertakes to respect the privacy of users, to treat personal data with caution and maintain confidentiality and shall not use it for purposes beyond those set forth here below.

For this purpose, this policy describes the procedures to manage the website in terms of the personal data treatment of users who access it.

This Policy may be changed or updated at any given moment by Jindal Saw Italia S.p.A.

The privacy statement only refers to this website and not to any other websites actually accessed by user through other links.

1. Owner of the data treatment

The owner of the data treatment is: Jindal Saw Italia S.p.A., Via K.L. Von Bruck, 32 34144 Trieste (Trieste), hereinafter also "Jindal Saw".

2. Data and purpose of the treatment

Jindal Saw informs users of the website that the data collected shall be exclusively used for the purposes here below. The data subject of the treatment is browsing data and those willingly supplied by user.

a) Browsing data

Computer systems set up to run the websites acquire several data needed to run the platform and information whose transmission is implicit for those protocols used for internet connection and browsing.

Some information related to the browser session and general data on the device utilized by user are also acquired. All data are acquired anonymously and cannot anyhow be traced back to a specific user or for profiling purposes.

b) Data voluntarily supplied by user - work with us area

User, in order to access some services of the website ("work with us") shall supply Jindal Saw with several types of data in a spontaneous form, prior to reading this privacy statement and after permitting the treatment for one or more of the purposes listed here below

Jindal Saw shall use the data collected for:

- a) purposes related to use of the services offered by the website (website browsing);
- b) activities strictly connected and instrumental to manage the relations with clients and potential collaborators (contact requests);
- c) marketing activities, even after any specific consent by user, for market research; business and statistical surveys; sending advertising/information/promotional material, sending newsletters also related to programs and promotions, even online, communications, development and maintenance of business relations.

d) treat the data related to curricula to evaluate work candidacies

Granting permission to use data for the purposes related to letter c) is optional and must be provided following the procedures explicitly set forth by article 7 of the GDPR, directly at the website.

Communications related to any marketing activities can take place through traditional procedures (e.g.: ordinary mail, phone calls with an operator), automated (e.g: phone calls without an operator) and which can be assimilated (e.g.: fax, email, sms, newsletter).

Notwithstanding any disagreement, Jindal Saw can continue to send its own clients business communications related to similar services they are already using.

3. Treatment procedures

The treatment of the data shall be made pursuant to Art. 4 n° 2) of the GDPR through these operations: collection, registration, organization, filing, consultation, processing, changing, selecting, extraction, comparison, use, interconnection, block, communication, cancellation and destruction of data.

The data shall be subject to paper, electronic and/or automated treatment.

The data starting from their receipt/update, shall be kept for a suitable period of time in terms of the above mentioned treatment. For further information regarding the period of time the data shall be kept please write to privacy@jindalsaw-italia.com.

4. Communication and transfer of data

The data, subject of the treatment, will not be circulated; they can however, for the purposes indicated in this privacy statement, be communicated to third parties, amongst whom business partners, advisors and freelancers, banks and credit institutes, insurance companies, financial, factoring, leasing, services firms, debt management and recovery companies, auditors, debt recovery companies, public bodies, auditing and surveillance authorities, in order to fulfill all law obligations, regulations, community laws or for aspects concerning the management and performance of current or past juridical relations with you.

The data shall be treated by the following parties:

- Employees of the companies who operate as authorized persons for the treatment of the data based on the roles performed and who are suitably trained.
- External managers pursuant to Art.28 GDPR.

The list of the Managers for the treatment of personal data is available at the registered office of Jindal Saw Italia S.p.A..

For all purposes indicated in this privacy statement, the data can also be disclosed abroad, in and outside the European Union, in compliance with the rights and warranties prescribed by current laws, prior to checking that the country in question guarantees a "suitable" level of protection pursuant to what is set forth by the GDPR.

5. Rights of the interested party

Please note that as interested parties, at any given moment you can ask to:

- a) access your personal data;
- b) change them in case of inaccuracies;

- c) cancel them;
- d) limit their treatment;
- e) the right to object to the data treatment where there are the preconditions;
- f) the right to data transferability, meaning the right to receive the personal data supplied in an organized form of common use and readable from an automatic device.

For what has not been explicitly prescribed by the provisions hereby recalled, please read the entire current law on Privacy and specifically articles 15, 16, 17, 18, 20 and 21 of the GDPR.

6. Revoking consent

The data shall be treated by the following parties:

- Consent can be revoked at any given moment provided this does not:
- prejudice any further treatment of the same data based on other legal grounds like for instance contractual or law obligations.
